Directions:
From Interstate 295:

- Exit Interstate 295 at Exit #32 (Haddonfield, Voorhees, Gibbsboro). At top of exit ramp, take Route 561 East towards Voorhees.
- Follow Route 561 East for 4.0 miles (you will pass approx 10 lights). Some landmarks – you will pass Woodcrest Country Club, Eagle Plaza shopping center, the Chop House restaurant. Your next to last light will be Clementon Avenue (there is a Dunkin' Donuts at the left corner).
- After passing Clementon Avenue, turn LEFT onto Kresson-Gibbsboro Road (there is a Wawa at the left corner).
- Follow Kresson-Gibbsboro Road 1.0 mile to the first traffic light. Turn RIGHT onto Cooper Road.
- Follow Cooper Road 1.5 miles to light at Route 73. Stay on Cooper and cross over Route 73. Approx ¼ mile after crossing Route 73, turn LEFT into entrance to Sturbridge Woods. You will be on Forrest Hills Drive.
- Follow Forrest Hills Drive. After passing Ashton Drive and Andover Court (both on the left), Forrest Hills will fork – go LEFT at the fork. Make your first LEFT into Foxboro Court. We are at the end of the court on the right.

From Routes 70 & 73:

- From the Olga's Diner circle (intersection of Routes 70 & 73), take Route 73 South.
- Continue on 73 South approx 5 miles south of Olga's Diner circle. Some landmarks – Champ's, the Promenade Shops at Sagemore, Target and Ventura's restaurant. Your next to last light will be Signal Hill Drive/Lakeside Avenue.
- After passing Signal Hill, turn LEFT at light at Cooper Road. There will be a Niagara Pools on the left and Cooper's Plaza shopping center on the right.
- After turning left on Cooper, make your first left into entrance to Sturbridge Woods. You will be on Forrest Hills Drive.
- Follow Forrest Hills Drive. After passing Ashton Drive and Andover Court (both on the left), Forrest Hills will fork – go LEFT at the fork. Make your first LEFT into Foxboro Court. We are at the end of the court on the right.

From Washington Township:

- Take Berlin-Cross Keys Road to the Berlin Circle and get on Route 73 North. Go approx 2 miles to the 3rd traffic light to Cooper Road and make a RIGHT onto Cooper.
- Follow Cooper Road approx ¼ mile and turn LEFT into entrance to Sturbridge Woods. You will be on Forrest Hills Drive. Follow Forrest Hills Drive. After passing Ashton Drive and Andover Court (both on the left), Forrest Hills will fork – go LEFT at the fork. Make your first LEFT into Foxboro Court. We are at the end of the court on the right.
